About the alliance

The Loddon Mallee Disability Alliance (LMDA) unites several NDIS-registered not-for-profit disability service providers operating in the Loddon Mallee region to advocate for a better NDIS.

Key Issues and advocacy Points

- 1. Fair NDIS pricing for regional Australians:
 - Advocating for equitable pricing structures within the NDIS to ensure that people with disabilities in regional areas receive the same quality of care and support as those in metropolitan areas.
 - Disparities in funding and service availability disproportionately affect regional participants, creating barriers to accessing necessary supports.

2. Addressing unmet needs and service gaps:

- Highlighting significant gaps in service provision within the NDIS framework, particularly in regional areas.
- Advocating for reforms to address unmet needs and ensure reliable, high-quality services.
- Cases where participants have been let down by unregistered providers, insufficient funding, and systemic issues within the NDIA.

3. Unfunded work and duty of care:

- Recognising that LMDA members often take on unfunded work to support participants due to a keen sense of duty of care.
- Calling for a review of funding models to include provisions for critical support work that is currently unfunded.

4. Strengthening advocacy and support:

- Committed to pushing for policy changes, increased funding, and better oversight of service providers to prevent exploitation and ensure accountability.
